Costalara 2018, the latest vintage from Pagos de Anguix, the reflection of a unique terroir

A historic vintage of an exceptionally ageworthy Tinto Fino varietal wine.

After J&C Prime Brands acquired the winery in 2018, the Juvé family poured passion, respect, and a deep appreciation for the region into the project, which has resulted in Costalara 2018, the first wine produced in collaboration with Juvé & Camps's technical team.



Burgos, December 2020 – This marks the release of Costalara 2018, a historic vintage of an exceptional Pagos de Anguix wine.

This Tinto Fino varietal originates from the heart of Ribera del Duero, home to the Pagos de Anguix winery and vineyard, which lies at an elevation of 850 metres. The vines grow in rocky soils over a calcareous clay substratum, and the wine is aged in French and American oak for 12 months.

Costalara 2018 has a bright red hue with violet nuances, deep intensity of colour, and persistent legs. The nose reveals elegant oak-imparted aromas of vanilla, coconut, and white pepper with notes of oregano. The complexity of the wine increases as it opens up, offering notes of liquorice root and high-intensity red fruit. Unctuous yet fresh in the mouth, with velvety tannins that envelop the palate and bring out its full richness.

The 2018 vintage required rigorous work in the vineyard to limit crop production and resulted in a harvest of optimal ripeness and concentration, perfect for producing ageworthy wines.

Costalara 2018 is a lush, concentrated, persistent wine with a long, spicy finish. This complex, modern wine will improve with bottle ageing over the next few years.

Pagos de Anguix, the Juvé family realises its Ribera del Duero dream

Pagos de Anguix is the Ribera del Duero winery of the J&C Prime Brands group, a project that marks the culmination of the Juvé family's dream of establishing a presence in this exceptional Spanish wine region. After acquiring the winery in 2018 and pouring passion, respect, and a deep appreciation for the region into the project, the Juvé family now presents Costalara 2018, the first wine produced in collaboration with Juvé & Camps's technical team.

As the name indicates, the winery is located in Anguix, a municipality in the far north of the appellation of origin, where cultivation is limited due to climate conditions. The estate has 77 hectares under vine, of which 35 are certified organic (these belonged to the Campos Góticos winery, a renowned pioneer of organic viticulture in the region, which J&C Prime Brands also acquired). The remaining vineyards are currently in transition to organic farming and awaiting certification.

The Pagos de Anguix vineyards lie at an average altitude of 850 metres and are between 20 and 40 years old. The parcels are exclusively planted with Tinto Fino, the raw material for wines that are meant to have a long life. Made with great care and attention to detail, the wine then matures in the cellars, and its slow evolution in the bottle guarantees that on release it will be at its absolute prime.

Helmed by the Juvé family, J&C Prime Brands comprises a group of four prestigious brands in the wine sector: Juvé & Camps, Propietat d'Espiells, Primeras Marcas, and Pagos de Anguix.
